The Cyrus Vance for Manhattan District Attorney campaign has a self-imposed limit of \$10,000 per four-year cycle per individual or entity. Total contributions from a corporation may not exceed \$5,000 per calendar year aggregate to all New York state and local candidates and committees, per New York State campaign finance law. Partnerships that contribute in excess of \$2,500 total over the course of the four-year cycle will be required to specifically identify the partner(s) responsible for the contribution(s), and the attributed amount will be counted against each partner's individual contribution limit; partnership contribution limits will be capped at an aggregate of each individual partner's \$10,000 limit.

The Cyrus Vance for Manhattan District Attorney campaign will not accept contributions from individuals, entities or their attorneys who have any case or investigation pending before the Manhattan District Attorney's Office, or who have had any case or investigation resolved by the Manhattan District Attorney's Office in the past six months. The campaign will only accept up to \$3,850 from partners of attorneys who have any pending case or investigation before the Manhattan District Attorney's Office, or who have had any case or investigation resolved by the Manhattan District Attorney's Office in the past six months. If an individual or entity has any case or investigation brought by the Manhattan District Attorney's Office within six months following a contribution being received, that contribution will be refunded or, as appropriate, donated to charity. An attorney's contribution will be refunded if the attorney begins to represent a client in a case or investigation brought by the Manhattan District Attorney's Office within six months of the attorney's contribution. If a contribution was made by the attorney's law partner, the contribution will be returned to the extent the amount exceeded \$3,850.

The Cyrus Vance for Manhattan DA campaign reports all contributions received, even if they are below the legal itemization threshold. Contributions are not tax deductible.
